ELEGIBILITY: Open to any competitor that have not at any time within the past 60 months preceding this event engaged in the personal use of Anabolic Steroids or any other oriented drugs in any form or matter whatsoever.

DIVISIONS: Novice One Men, Novice One Women, Novice One Figure, Open Men, Open Women, Master Men 50 and, Over Master Women 50 and Over, Master Figure 50 and Over, Teenage, Novice Two Men, Novice Two Women, Novice Two Figure.

INFORMATION: All competitors competing in the novice one class must not have ever competed in a bodybuilding or figure competition in the past. Competitors will be divided by height based on the number of entry's. Posing routines are to be no more than 90 seconds long in both the pre judging and the evening show. **No music with racial or profanity words will be allowed. Only posing attire is allowed to be worn on stage. Props that are attached to the body will be allowed at the evening show. To compete in the novice Two division you must not have won first place in a show where there were three competitors or less competing in your division.**

E.P.F.N.B CARDS: All competitors must be in good standings with Executive Productions and must have an Executive Productions card in order to compete in this competition. Membership cards will be sold at the contest site for \$40.00. Applications can be attained by logging onto **epfnb.org**.

DRUG TESTING: Drug testing will take place **October 9, 2010 between 10:00am and 11:00am** at the University of Michigan Theatre.
