**INFORMATION:** All Competitors competing in the novice division one class must not have ever competed in a bodybuilding or figure show in the past. **Competitors will be divided by height based on the numbers of entries. Lyrics of all music must be in good taste. No music with racial or profanity lyrics will be allowed. Only posing attire is allowed to be worn on stage.** Props that are attached to the body will be allowed at the evening show. All Competitors competing in the novice two division must not have won a bodybuilding or figure show in the past where there were three people or less competing in there class.
